## COLONIAL RULE AND POLITICAL DEVELOPMENT IN TANZANIA

#### The Case of the Makonde

by J. Gus Liebenow

This study analyzes the effect of external forces, primarily British colonial rule, on the Makonde society, the third largest tribal group in Tanzania, and assesses their essentially negative impact on the political, social, and economic development of the Makonde and the nation. Possessing few economic attractions for European investors, the Makonde region remained out of the mainstream of Tanganyikan development, permitting the local colonial administrators to indulge their ideas and to institute, often without restraint, serious changes in the Makonde's economic, social, and political institutions. The "white man's madness" of colonial administrators was the most significant factor in undermining the confidence of the Makonde in the concept of modernization, an influence still present today, and manifested in Makonde difficulties in responding positively to President Nyerere's policies of national development and self-reliance. This study reflects the author's conviction that students of African politics must pay greater attention to developments at the local level, where the rhetoric of prescription and aspiration gives way to actual political relationships.

# AFRICAN MUSIC ON LP An Annotated Discography

by Alan P. Merriam

This comprehensive listing of 390 LP and EP recordings of African music published in the last decade is annotated and organized around an alphabetical listing of the record companies or producing organizations. Information is given on the notes on the record jacket or within the album; the circumstances of recording; names of individuals associated with it; names of performing groups and individual artists; photographs in the album; type of music; cross references to other issues of the same record; and special remarks. Annotations of the 2,716 bands include the title of the song or instrumental piece; tribe represented; name of performing group or individual; language of song text; type of song or instrumental piece; musical instruments used; composition of singing groups; stylistic characteristics of the music; and specific information on the circumstances of recording. Especially useful are the eighteen indexes which also contain this information.

The author studies the Africans as agents helping to make their own history and examines the various ways in which they sought to retain self-respect in the colonial situation and to mold their own lives, and presents a detailed case for a series of connections between the politics of this period and the development of later mass nationalism.
