The minutes of last fall's Workshop on business and institutional history published in the March issue of the JOURNAL include a report of my comments on the editorial policies of the *Business History Review*. I was surprised and dismayed to see emphasized in that report a statement that I did not intend as a description of the *Review*'s policy and that no one familiar with the *Review* could accept as an accurate description of its practice.

I want to emphasize here that the selection policy of the *Review* is not based on ideological grounds. The *Review* welcomes any articles, including those written by Marxists, followers of Ayn Rand, members of the Chicago School, and adherents of any other philosophy.

Publication of a contribution depends not upon its ideological viewpoint but on its fulfillment of standards of scholarship enforced through a process practiced by the editor of the *Review* and its predecessor for many years. A memorandum outlining these policies and procedures is available to any interested person upon request.

I was not given the opportunity to review or correct the minutes before they were published. Certainly I would not have included the statement in question in any official report of my comments.
