Modern Logic, like mathematics, is a highly specialised subject with an extensive technical literature. But unlike mathematics it is a relative newcomer to the academic scene. While it is true that the initial stages of its development took place several hundred years ago, it made its debut only as recently as the beginning of the present century. Since then it has progressed so rapidly that few text-books on the subject can hope to be comprehensive. A compromise between breadth of coverage and depth of treatment seems inevitable. The present series is designed to meet this problem. Each monograph devotes separate attention to a particular branch of modern logic, the level of treatment being intermediate between the elementary and the advanced. In this way a wider coverage of this subject will, it is hoped, be made more accessible to a larger number of readers.
