In this study Jürgen Becker presents a new, historically grounded explanation of the phrases "kingdom of God" and "God's reign" - the central terms of Jesus' proclamation. The author, a professor of the New Testament, draws on an impressive range of sources to trace Jesus' special position within early Judaism. At the same time, he retains his focus on Jesus' ministry, viewed as the beginning of the history of early Christianity. The proclamation of the kingdom is thus seen by Becker as the founding moment of a distinct community of faith.

The author should certify that the article is not being submitted simultaneously to some other journal and explain to the editor the extent of any overlap with books or articles the author has published or is about to publish. Articles which simply reproduce material that has appeared, or is due to appear, elsewhere in the same or a different language should not be submitted to this journal.

Upon acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press.

Contributors are responsible for obtaining permission to reproduce any material which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their manuscript.

MANUSCRIPT PREPARATION

New Testament Studies accepts contributions in English, French and German. All articles submitted for publication in this journal are expected to conform to the requirements of the full instructions for contributors which can be found in NTS 38 (1992) 157-160 and on the www at http://www.cup.cam.ac.uk/journals/jnlscat/nts/nts.html. Typescripts should not normally be longer than 8,500 words including footnotes. The typescript of both text and footnotes should be double spaced. Typescripts which exceed this limit cannot be considered for publication. Two copies of a typescript should be submitted to the editor. Contributors are also asked to supply an abstract of their article, not exceeding 100 words in length. Short Studies may be supplied without an abstract.

When an article has been accepted for publication, the author is strongly encouraged to send a copy of the final version on computer disk (Macintosh or PC) together with the hard copy typescript, giving details of the wordprocessing software used (Microsoft Word or Word Perfect). However, the publisher reserves the right to typeset material by conventional means if an author's disk proves unsatisfactory.

PROOFS

Typographical or factual errors only may be changed at proof stage. The publisher reserves the right to charge authors for correction of non-typographical errors.
