## THE CONTRIBUTORS

RAYMOND TANTER, Associate Professor of Political Science and Director of the International Data Archive project at the University of Michigan, served during 1967 as Deputy Director of Behavioral Sciences of the Advanced Research Projects Agency, Department of Defense, and is presently a consultant to the Rand Corporation. His special interest is the creation of computer-based systems for modelling and managing international conflicts.

RICHARD H. ULLMAN, Professor of Politics and International Affairs at Princeton University, is the author of a three-volume study of Anglo-Soviet relations in the aftermath of the First World War. He has served on the Staff of the National Security Council, and on the Policy Planning Staff in the Office of the Assistant Secretary of Defense for International Security Affairs.

GRAHAM T. ALLISON, Associate Professor of Politics in the John F. Kennedy School of Government at Harvard University, is the author of *Essence of Decision: Explaining the Cuban Missile Crisis*.

MORTON H. HALPERIN, a Senior Fellow of the Brookings Institution, was formerly a member of the Senior Staff of the National Security Council and a Deputy Assistant Secretary of Defense. He is currently at work on a book on bureaucratic politics and foreign policy in the United States.

NAZLI CHOUCRI, Assistant Professor of Political Science at the Massachusetts Institute of Technology, is the author and co-author of numerous articles on the analysis and forecasting of international conflict behavior.

ROBERT C. NORTH, Professor of Political Science and Director of Studies in International Conflict and Integration in the Institute of Political Studies, Stanford University, is the author of *Moscow and Chinese Communists* and other books and articles concerned with international relations, international conflict, crises, and the antecedents of war.

EDWARD L. MORSE, Assistant Professor of Politics and International Affairs at Princeton University, is the author of a forthcoming book, *France and the Politics of Interdependence, 1962-1969*.

NORMAN FROHLICH and JOE A. OPPENHEIMER are assistant professors of Government at the University of Texas. They are co-authors (with Oran R. Young) of *Political Leadership and Collective Goods*, and are currently working together to develop an axiomatic theory of coercive relationships.

ORAN R. YOUNG is Professor of Government at the University of Texas. His most recent book is *Political Leadership and Collective Goods* (with Norman Frohlich and Joe A. Oppenheimer). He is currently working on models of strategic interaction and bargaining.

DAVIS B. BOBROW is Professor of Political Science and Public Affairs and Director of the Center of International Studies, University of Minnesota. Prior to that, he was Special Assistant for the Behavioral and Social Sciences in the Office of the Director of Defense Research and Engineering, and Acting Director, Behavioral Sciences, Advanced Research Projects Agency. His major current interests are in indicator systems for anticipating and evaluating international policy and the design of public institutions.

## THE CONTRIBUTORS

ALLEN S. WHITING, Professor of Political Science and Associate for Chinese Studies at the University of Michigan, is the author of *China Crosses the Yalu: The Decision to Enter the Korean War*, and of other studies on Chinese and international affairs. He served in the Department of State from 1962-66 as Director, Office of Research and Analysis for Far East, Bureau of Intelligence and Research. From 1966-68 he was Deputy Consul General in Hong Kong.
