

Are you a Registered Nutritionist?

The Nutrition Society

The Society's register is part of a framework of activities that set and promote high standards of education and that support professional development in nutrition. The register helps employers, the media and the general public to identify appropriately qualified individuals. Members on the register are expected to adhere to the Society's Code of Ethics. The Nutrition Society's Register replaced the Register of Accredited Nutritionists, run by the Institute of Biology in conjunction with the Society. Individuals who qualified as Accredited Nutritionists transferred to the Society's register in 1999. The Register is published on the Society's website and, from time to time, in printed form.

Register of Nutritionists

Members of the Nutrition Society have the opportunity to apply for Registration in Nutrition that enables the individual to use the title *Registered Nutritionist* and the letters *R Nutr* after their name. Members of the Society who have been working in the field of nutrition for a minimum of three years and who have academic qualifications in nutrition, dietetics or a related subject are eligible to apply. Certain other relevant qualifications may also be acceptable.

Associate registration

Members with appropriate qualifications who have not worked for at least 3 years after graduating may also apply for registration as Associate Nutritionists. This confers the title *Associate Nutritionist* and letters *Assoc Nutr*.

How to Apply

Send a recent CV, photocopied qualification certificate(s) and the names of THREE academic and/or professional references to the Society's Registrar.

Register of Public Health Nutritionists

The Society has a policy to develop specialist categories of the general Register to cater for members with specialist expertise. In 1997, the first, a Register of Public Health Nutritionists, was launched. Members of the Society who have been working in the field of Public Health Nutrition for a minimum of three years in the last five and who have appropriate qualifications are eligible to apply. Members who fulfil the criteria for registration are able to use the title *Public Health Nutritionist* and the letters *RPHNutr* after their name.

How to Apply

Send a recent CV, photocopied qualification certificate(s) and the names of TWO academic and/or professional references to the Society's Registrar.

Associate registration

Members who qualify from accredited courses and who have not worked for at least 3 years after graduating are eligible for registration as Associate Public Health Nutritionists. This confers the title *Associate Public Health Nutritionist* and letters *Assoc. PHNutr*.

Directions to Contributors – Concise Version

The *Proceedings of the Nutrition Society* publishes papers presented by invitation and original communications given at the symposia and meetings of the Society. The geographical scope of the journal is international. As a contributor you should note and follow the guidelines set out below. For further information on how the technical content of your paper should be presented please see the **Directions to Contributors** on the Nutrition Society web pages at <http://www.nutsoc.org.uk/directions.htm> as reproduced in the first issue of a recent volume of the *Proceedings* (February), or contact the Publications Office on +44 (0)20 7371 6225 (telephone) or +44 (0)20 7602 1756 (fax) or edoffice@nutsoc.org.uk (email).

Papers should be accompanied by a signed statement to the effect that the author accepts the conditions laid down in the full Directions to Contributors.

Contributors of Symposium papers will be asked to complete a copy of the 'licence to publish' (in lieu of copyright transfer) at the proof stage.

Page format. The *Proceedings* is printed in double-column format (column width of 85 mm) with a text area of 235 × 177 mm.

Text. Papers should be typed, on one side of the paper only, with double line spacing and margins (at least 1.5 cm) on each side and with no underlining or bold in text except for scientific names. Draft-quality print from a word-processor is not acceptable. Standard abbreviations (e.g. Fig. and Figs.) and SI units must be used. **When a paper has been accepted, word-processed text stored on floppy disk is encouraged, providing the software is IBM/DOS compatible, but floppy disks must be accompanied by a hard copy. This will enable papers to be handled rapidly, and with fewer typesetting errors.**

Synopsis. Each paper must commence with a carefully prepared, accurate, informative synopsis, in one paragraph, that is complete in itself and intelligible without reference to text or figures. It should not exceed 250 words.

Key Words. Authors should supply two or three key words or phrases (each containing up to three words) for the subject index of the volume.

Tables. Tables should be reduced to the simplest form, and should not be used where text or illustrations give the same information. They should be submitted on separate sheets at the end of the article and must carry headings describing their content that are comprehensible without reference to the text.

Illustrations. The original illustrations should accompany the manuscript for submission. Text figures, line drawings, computer-generated figures and graphs should be of sufficient size and quality to allow for reduction by half or two-thirds. Half-tone photographs are acceptable where they are a real contribution to the text. Figure captions should be typed on a separate sheet and numbered corresponding to the relevant figures.

References. References must be based on the name and year (Harvard) system; **give full journal titles** and conform to the following styles:

Citation of authors in the text should appear in the form: de Deckere *et al.* (1998) or (de Deckere *et al.* 1998). More than one author should be cited in chronological order as: (Marcus *et al.* 1996; Cinti *et al.* 1997).
