Most California history has been written as if white men, i.e. Spaniards, Californians, and Anglo-Americans, were the only important instigators of events and trends. Indians are usually viewed as passive, helpless witnesses to their own destruction, doing nothing to solve the problems created by incoming whites and thereby having little influence on the historical process.

In this pioneering study Mr. Phillips has pulled together a large body of historical and ethnographical data to show that Indians in southern California shaped much of its early history.

Many books have been written about the California Gold Rush but a geographical historical dictionary has long been lacking. With the publication of *California Gold Camps*, a monumental project has been completed.

The California mining camp has been described as ephemeral. Sometimes it grew into a town or city. Oftentimes, however, the camp flourished and grew, only to decay and disappear within a few years. Sometimes the camp had no name and was designated by the name of a topographic feature. The book deals mainly with camps which originated in the wake of Marshall's discovery of gold on the South Fork of the American River in January of 1848 and in the golden era which followed for a period of less than two decades.

WATER AND THE WEST

Water is one of mankind's greatest concerns, and few areas are more aware of it than Western America. This work is about the greatest conflict over water in the American West; more precisely it is about an alleged peace treaty—the Colorado River Compact of 1922. The Colorado River is the sole dependable water supply for an area of 244,000 square miles, yet it carries enough water for only a handful of cities, industries, and farms, condemning most of the West to remain a desert. This stark reality was at the heart of the movement for an interstate treaty among the seven basin states and the federal government, and it remains at the heart of the disputes over water that still rock the West.

SOUTHERN POLITICS AND THE SECOND RECONSTRUCTION

Hugh D. Graham and Numan V. Bartley

There has been no regional analysis of southern politics like this one since V. O. Key's modern classic of 1949. Focusing on the South's Second Reconstruction from 1944 to 1974, this study of partisan realignment confronts the question of whether southern politics was transformed from a one-party system into a two-party competitive system or even a one-party Republican system. During that time, the four basic institutions that supported the Democratic South were destroyed: the one-party system, disfranchisement, malapportionment, and the Jim Crow caste system of racial segregation.

The authors provide their historical narrative of southern politics based on a massive analysis of voter returns from every county in the South since World War II, plus selected precinct returns from twenty-seven southern cities and a computer analysis of survey research data.

NOTES FOR CONTRIBUTORS

1. All contributions and editorial correspondence should be sent to: The Editor, *Journal of American Studies*, Department of American Studies, The University, Manchester M13 9PL, England.
2. Articles should generally contain about 5000 words. Longer or shorter articles, or articles in two or more parts, may be accepted by arrangement with the Editor.
3. Submission of an article is taken to imply that it has not previously been published, or is not being considered for publication elsewhere.
4. Contributions should be clearly typed in double spacing, preferably on A4 paper, with a wide left-hand margin. Diagrams and maps may be included by arrangement with the Editor.
5. Footnotes should be used sparingly: in general, to give sources of direct quotations, references to main authorities on disputable questions, and evidence relied on for a new or unusual conclusion. They should be numbered in one sequence throughout the article, and should preferably be typed in double spacing at the end of the article.
6. Contributors should keep one copy of the typescript for correcting proofs.
7. Notes intended for the Editor or printer should be on a separate sheet.
8. First proofs may be read and corrected by contributors provided that they can give the Editor an address through which they can be reached without delay and can guarantee to return the corrected proofs to the Editor, by airmail where necessary, within ten days of receiving them.
9. Correction should be kept to an absolute minimum. It should be confined to errors of the typist or printer unless the Editor authorizes otherwise.
10. Contributors of articles and review articles receive 25 free separates. Extra copies may be ordered according to the scale of charges.
11. Contributors need not be members of the British Association for American Studies. Unsolicited typescripts can only be returned to overseas contributors who send International Reply Coupons (not postage stamps).
12. Contributors of accepted articles will be asked to assign their copyrights, on certain conditions, to Cambridge University Press, to help protect their material, particularly in the U.S.A.
