It was not my intention to comment on clinical matters such as diagnosis or treatment. Dr Anderson has assessed the patient while I have not. If the outcome of these assessments is that she has an illness requiring ECT, then I accept this entirely and hope that she responds favourably.

My purpose was to emphasise the importance of social factors in psychiatric practice, especially the matter of compulsory admission. Disturbed, deviant, or merely difficult behaviour may be presented as evidence of mental illness, and psychiatrists should be particularly aware that such behaviour in the absence of other features must be viewed with reserve. Diogenes after all was not mentally ill.
