This issue features the last of Dr Nicholas James's book chronicle, known to readers of Antiquity as 'Among the New Books'. The review section, produced since March 1999 under his erudite and elegant editorship, will now come from York and take on the challenge of channelling the tide of new publications. No dramatic changes, but a few innovations, are proposed. 'Among the New Books', now re-named 'New Book Chronicle' will continue to chronicle all the publications received by Antiquity that are not the subject of a review or review article, but commentary will concentrate on a few themes each issue. All the other books will be listed under topical or geographical headings, as before. Space being at a premium, the review section has, after two years' experimentation with a larger font, reverted to a smaller print size. It is very much hoped that these small losses will result in a more streamlined look and more space for reviews. Finally, as there is an inevitable time lag between the publication of a new book and its review in these pages, we propose to alert readers to the arrival of new books as soon as they land on Antiquity's doormat, by listing new publications on Antiquity's website. The listing of a book in 'Books Received' - continuing Crawford and Daniel's policy - will not preclude its subsequent review. Antiquity, as always, would welcome comments and suggestions on the new look review section.

Tres Zapotes has long been recognised as a major Olmec site. Surveys by Pool & colleagues now provide more systematic context. His argument for nucleation without centralisation chimes with various other Mesoamerican sites and urban traditions – but not all other Olmec 'centres'; and it would be worth

considering further afield too. LINNÉ's report, first published in 1934, 'is of exceptional and lasting importance', avers G.L. Cowgill (p. xiv).

With a strong sense of theoretical perspective, M. SMITH introduces 11 studies of development. G. Cowgill, first, repeats the suspicion that Teotihuacan, Mexico, formed rapidly by dint of both free will and compulsion but warns, of course, that both causes were filtered through values now indiscernible. For 'Urban Clusters' in Mali, McIntosh & McIntosh confirm (p. 117) that 'we must ... experiment ... with research that might open a window upon ancient motivations'; and SMITH herself revives an archaeological mainstay by arguing that, in India & Bangladesh, 'walls, monumental gates, and other forms of labour-intensive architecture' (p. 282) signalled identity to visitors and, for locals, community in their own 'small worlds'. The argument (C. Attarian) that Early Intermediate pottery in the Chicama Valley, Peru, testifies to a new 'group identity' is pertinent to Teotihuacan; and all the more, considering the contrary case (J. Moore) for elitism later in the same region of Peru or, by extension (J. Yaeger), detection of social disparities in development at Maya Xunantunich. Again, for Maya Piedras Negras, where, like both Xunantunich and Teotihuacan, rise and fall were rapid, S. Houston et al. argue (p. 240) that 'purely ecological explanations ... do not ... explain ... why cities exist and when...although they do help determine where': 'Kingship and kings must have played a role ... regardless of ... decisions ... by individual families or lineages'. C. Shen considers the emergence of private enterprise in the erstwhile Zhou royal city of Yan-Xiadu, China. A couple of contributions on Mesopotamia are devoted to economics and less with ethos: to neighbourhood trades and (M. Zeder) food supply. Stimulating in Viking Age are brief discussions of the sources of wool and silk and, especially, of customs of costume public and domestic: were 'prince and merchant, housewife and artisan closely linked in their daily life' (p. 109)? The detailed description and analysis of 68 textiles has been finely produced.

Tarquinia, unlike Tres Zapotes and The social construction, takes our interest in its subject for granted and, partly, perhaps, on that account, while the text is thoroughly learned and informative, much of the archaeological reasoning is incomplete. Having reviewed the rich tombs, for example, Leighton remarks (p. 65), 'Overall, therefore', they 'project power in a manner typical of early states in a phase of growth':

'sheer ostentation'. Even were the generalisation valid, since neither 'power' nor 'early states' are defined or explained, 'therefore' assumes too much.

NANCY BENCO & team report on digs that sampled early Islamic levels. They cover survey of part of the turreted town wall and of a cemetery; animal bones and botany; pottery and (very effective) tiles and the implications for roofing. There is a small attempt at the archaeology of women. Archaeomagnetic samples, though inconclusive, were compatible with surprisingly early radiocarbon dates. Also included is an analysis of the regional settlement pattern.

FINN's theme, appropriately to his evidence, was worked out, no doubt, *post facto*: rescue revealed traces from prehistory beneath a Roman road and roadside features; Saxon evidence included a Grubenhaus; and Medieval wells and other features were covered by remains of craftwork and by Civil War defences, after which the site was occupied by more substantial buildings. The report includes 17 specialists' contributions. *Birmingham* tries to illustrate the same pattern for general readers who, it should, indeed, be assumed, must be interested. It shows clearly enough that most of the great city was country until the Industrial Revolution.

Shifting sands is a firmly conceived, closely researched, clearly written and detailed chronicle starting from the research of the US philologist, Edward Robinson, who first arrived in Palestine in 1837/8. Davis goes on to consider the establishment of the Palestine Exploration Fund and the Society of Biblical Archaeology, and the investigations of A.H. Sayce, Petrie and his successors, the Germans, and Reisner (a 'Calvinist approach to recording' [p. 44]). Steeped in the pottery, W.F. Albright, he explains, brought 'Biblical archaeology' to maturity - and had to stave off the accusation of fundamentalism. G.E. Wright then sought to develop positivist research but, argues Davis, succumbed to interpretive circularity. Davis disagrees with W.G. Dever's assertion that 'Biblical archaeology' failed for lack of method: 'The only flaw lay in the understanding of the sought answers as objective data untouched by the questions' (p. 155).

Like qualities of concept, research and writing distinguish The discovery. Ms Singh's very satisfying account is built around the career of Alexander Cunningham, a determined visionary, it transpires, indefatigably concerned for the archaeology on the ground. She runs from the early nineteenth century antiquaries to Cunningham's 'enthusiastic apprentice', Beglar, and a tempered reassessment of A.C.L. Carlleyle before turning to the controversial participation of Indians, from Ram Raz to R.L. Mitra and his argument with James Fergusson. With particular attention to Bodhgaya and Amaravati, she considers the issues for the recording, management and excavation of monuments and the preservation of antiquities, whether locally or in the Raj's capitals or in London. Her analysis of policies and interests at these three levels of the hierarchy is cogent and telling. Like Davis, she is alert to the mixture of impulses: 'Disinterested scholarship jostles', in nineteenth century India, 'with scholarship linked directly or indirectly to larger political agendas' (p. 338).

D.K. CHAKRABARTI, whose previous research helps to inform Singh's, resumes his own account with

the era of independence. He argues that, in India and elsewhere, 'archaeology in the colonial context was a small government-run affair which hardly played any role in ... education ... or in nationalist movements' (p. 213) and - holding no punches back in a broad yet detailed review of research, publication and monument management - that little has changed since the British. Alarmed by the spread of India's population, he bemoans inadequate provision for rescue (but who can foresee much improvement?). Urging that it is now necessary 'to develop' an 'image of their past in which ... ethnic groups are not related to a superior/inferior hierarchy' (p. 215) and calling for effective dissemination in regional languages, CHAKRABARTI sets out a radical interpretive framework for research in future. The Aryan hypothesis is dismissed as racist and demeaning but he is careful to delimit the connotations of the 'nationalist archaeology' that he promotes, 'uncluttered by the ambiguities of our literary tradition' (p. 276 [cp. DAVIS]), for revealing the 'firm and continuous ... sequence running through the land' from 'perhaps as early as the lower palaeolithic' (p. 275). His conviction and passion sustain the reader through various smallish flaws that the editors missed.

The archaeology of the British later Middle Ages too emerged from a weight of historians' assumptions. GERRARD finds it easy to expose the cultural influences on antiquarianism and archaeology up to the era of Gen. Pitt Rivers but his account of how, to 1945, the subject was then marginalised, and of its growth to 1970, depends more specifically on the history of universities (the rise of prehistory) and particular figures such as Crawford, Cyril Fox, M. Beresford, Hurst and Knowles. The ensuing twenty years are explained by reference to the sheer volume of rescue investigation, the first syntheses (C. Platt, H. Clarke et al.), and the methodological encouragements of M. Aston and C.C. Taylor. There follows an account of issues since. Medieval archaeology is well written and illustrated, the quality of learning up to the others' standard, in method like Davis and Singh, in the techniques of quantification and case study like SINGH and CHAKRABARTI; but, where the latter manages both to take critical advantage of his own experience (see 'Asia', below) and stands (very) well back, Gerrard's reporting of the period since 1970 is too simply descriptive and lacks his own quality of perspective on the 1800s.

Fifteen papers full of highly informative, satisfying and well organised detail, many excellently illustrated, are introduced by the late I. BIGNAMINI. They document a deeply formative phase of archaeology's history. This book is a very substantial contribution to our appreciation. It has been produced most elegantly. Prof. Kurtz introduces studies of *Classical art* as reflected in the history of the Ashmolean Museum and Oxford University's five related chairs. They cover 'Nudity' (J. Boardman), medals, maiolica, gems, and the museum's new Sackler Library (Robert Adam).
