

## **The Anglo-Saxons Synthesis and Achievement**

This collection, in examining many aspects of pre-Norman Britain, helps to illuminate how Anglo-Saxon society contributed to the continuity of knowledge between the ancient world and the modern world. But as well, it posits a view of that society in its own distinctive terms to show how it developed as a synthesis of radically different cultures.

An examination of the Bayeux Tapestry for its propagandistic content, the study of Old English literature extended to such works as laws, charters, apocryphal literature, saints' lives, and mythologies, a discussion of the institution of slavery, and an analysis of the use of Germanic warrior terminology in Old Saxon are among the material of the book that contributes to the descriptive analysis of that society's social groups.

"Once every decade there appears a book of such sweeping scope and scholarly substance that it makes a major contribution to its field. Joseph Washington's *Anti-Blackness in English Religion, 1500-1800* is such a work. His task is to provide an explanation for the tenacity and endurance of virulent anti-black values and feelings which persist today in the form of institutional racism in Britain and the United States. Washington's thesis is that anti-blackness was raised to the level of an ultimate concern so that a cultural religion of anti-blackness developed in England in the early 1500's and was later transferred to the American colonies by the English Puritans and the Anglican Church.

"Washington points out how the English religious tradition equated diabolical evil with blackness and thereby considered black people as subhuman. Not only theologians but literary greats such as William Shakespeare and Ben Johnson among others were deeply influenced by this tradition of anti-blackness. To Washington's credit his ethical analysis isn't a simplistic one of finding a racist under every rug. He deals with the contradictory tendencies of the English value system which not only produced the tradition of anti-blackness but also its opposite in the strongest, most effective antislavery and abolitionist movement in the West.

"This book with its extensive documentation and bibliography will be most useful as a resource book for graduate students and specialists, although undergraduate English courses on the Victorian period and Shakespeare can also profit from Washington's analysis."
