Contributors

Tamar Barzel is Assistant Professor of Ethnomusicology at Wellesley College. Her research interests include experimentalism, jazz, blues and blues-based idioms, “New York Noise,” and Jewish and African American cultural studies, especially with regard to intellectual history, diasporic identity, and the avant-garde. She is currently working on a book, provisionally titled “Downtown and Disorderly: ‘Radical Jewish Culture’ on Manhattan’s Avant-Garde Music Scene.”

Sujatha Fernandes, Assistant Professor of Sociology at Queens College and the CUNY Graduate Center, is the author of *Cuba Represent! Cuban Arts, State Power, and the Making of New Revolutionary Cultures* (Duke University Press, 2006). Another book, *Who Can Stop the Drums? Urban Social Movements in Chávez’s Venezuela*, is forthcoming in 2010. She is currently writing a memoir on global hip-hop that draws on her experiences in Sydney, Havana, Chicago, and Caracas.

Danielle Fosler-Lussier, Assistant Professor at The Ohio State University School of Music, is the author of *Music Divided: Bartók’s Legacy in Cold War Culture* (University of California Press, 2007). Her research on music and cold war cultural politics has been supported by fellowships from the American Musicological Society, the American Council of Learned Societies, the International Research and Exchanges Board, and the Mershon Center for International Security Studies.

Christina Gier is Assistant Professor of Musicology at the University of Alberta. She has published on gender discourse and singing in the U.S. military during the First World War and on Alban Berg, his modernist aesthetics, and gender discourse in *fin-de-siècle* Vienna. She is completing a book entitled “*Music will win the war!*” *Song, Identity and the Military in America during the First World War*.

S. Andrew Granade is Assistant Professor of Musicology at the University of Missouri–Kansas City Conservatory of Music and Dance. He received a Ph.D. in musicology from the University of Illinois with a dissertation on Harry Partch that was supported by an Alvin H. Johnson AMS-50 Fellowship. He is currently completing a study of the impact of the hobo on Partch’s life, work, and reception.

Bill Kirkpatrick received his Ph.D. in Media and Cultural Studies at the University of Wisconsin–Madison and is now Assistant Professor in the Communication Department at Denison University. He previously taught at the University of Michigan. His research interests include media policy and the history of broadcasting, and he is currently working on a book about localism in U.S. media.

Ingrid Monson is Quincy Jones Professor of African American Music at Harvard University. Her most recent book is *Freedom Sounds: Civil Rights Call Out to Jazz and Africa* (Oxford University Press, 2007). She has received many awards, including a Guggenheim Fellowship (2009), a Walter Channing Cabot Fellowship (2008), and

the Woody Guthrie Book Award of the International Association for the Study of Popular Music (2009).

Anna Nekola's research interests center on disputes over the moral and cultural value of popular musics. She received her Ph.D. in Musicology at the University of Wisconsin–Madison, where her dissertation, “Between This World and the Next: The Musical ‘Worship Wars’ and Evangelical Ideology in the United States, 1960–2005,” examined struggles surrounding the incorporation of popular music in Christian worship. She also maintains an active performance career as an oboist.

Ève Poudrier, Assistant Professor of Music at Yale University, holds a B.A./M.A. degree in piano and composition from Hunter College and a Ph.D. in Music Theory from the Graduate Center of the City University of New York. She has presented and published on topics such as the rhythmic language of Elliott Carter, Vincent d'Indy's theories of rhythm, and the perception of polymeter.

W. Anthony Sheppard is Professor of Music at Williams College, where he teaches twentieth-century music, popular music, film music, opera, and Asian music. His *Revealing Masks: Exotic Influences and Ritualized Performance in Modernist Music Theater* (University of California Press, 2001) received the Kurt Weill Prize. His work has also earned the ASCAP Deems Taylor and Alfred Einstein awards and has been supported by the NEH and the American Philosophical Society. He is currently completing *Extreme Exoticism: Japan in the American Musical Imagination*.

Catherine Parsons Smith (1933–2009) was Emerita Professor of Music at the University of Nevada, Reno. She authored four important books: *Mary Carr Moore, American Composer* (1987), *William Grant Still: A Study in Contradictions* (2000), *Making Music in Los Angeles: Transforming the Popular* (2007), and *William Grant Still* (2008), as well as a host of articles on these and other topics, notably music and feminism.

Albin Zak's research specialties are popular music studies and the history of sound recording. His articles and reviews appear in the *Journal of the American Musicological Society*, *Journal of the Society for American Music*, *Current Musicology*, *Notes*, and several essay collections. He is the author of *The Poetics of Rock: Cutting Tracks, Making Records* (University of California Press, 2001) and “*I Don't Sound Like Nobody*”: *Remaking Music in 1950s America* (University of Michigan Press, forthcoming).
