Empire and Liberty

American Resistance to British Authority 1755–1763

Alan Rogers

In the course of the eighteenth century Americans assimilated a radical political persuasion: a fear of power and a deep concern for liberty were its central tenets. For many Americans the legitimacy of this persuasion—which played such an important role in the making of the American Revolution—was verified during the Great War for Empire. While the struggle to drive France from the North American continent was being waged, Americans of every social class experienced first hand, or had some reason to fear, arbitrary British power. Rationalizing their aggressive behavior on grounds of military necessity, British generals imposed embargoes on colonial shipping, ordered press gangs to seize men and property, forced citizens to quarter soldiers in their homes, and insisted that the authority of colonial political agencies was subordinate to their own military power. This stimulated many Americans to question whether empire and liberty were compatible, and made radical political thought concrete and personally meaningful. Their belief that British imperialism presented a grave threat to American liberty was thus not an expression of political paranoia but a conclusion drawn from experience.

William Howard Taft

A Conservative's Conception of the Presidency
Donald F. Anderson

How a dedicated conservative perceived and used the powers of the presidency is here treated with authority, objectivity, and a dash of wit. The personal papers of William Howard Taft, only recently opened to the public, cast important new light on his aims and performance as president.

Comparing Taft with his eloquent and dynamic predecessor, Theodore Roosevelt, Mr. Anderson contrasts both their views of presidential power and their political styles. Finally, he places Taft in a larger historical context—as an apostle of constitutional democracy who valued the rule of law more than majority rule.

The Foundations of the American Empire

William Henry Seward and U.S Foreign Policy
Ernest N. Paolino

This persuasive and well-documented study of United States foreign policy in the period 1861-1869 focuses on the ideas and activities of Secretary of State William Henry Seward. The author presents a convincing portrait of Seward as primarily a commercial expansionist, closely associated with powerful mercantile and financial circles in New York City, whose major objective was to establish the global commercial hegemony of the United States. Professor Paolino shows that to achieve this end Seward supported the establishment of an intercontinental telegraph line; unification of the world's coinage; direct American involvement in Asia; and the acquisition of Alaska, the Isthmus of Panama, and certain Caribbean islands.

A Venture in History

The Production, Publication, and Sale of the *Works* of
Hubert Howe Bancroft
Harry Clark

Between 1874 and 1890 Hubert Howe Bancroft, a San Francisco publisher and bookseller, produced, from the resources of his unparalleled collection of books and manuscripts on the West, his *Works*—a 39-volume social and historical study of the western portion of North America. The volumes form the most detailed account of the region that has ever been written and are still used as reference tools.

Bancroft's use of assistants in the writing and his sanction of the sale by canvassing of the *Works* have embarrassed his apologists and delighted unfriendly critics, but both the hired writers and the book agents were necessary to complete the history. *A Venture in History* explores in detail the participation of both Bancroft and his associates in the production, publication, and sale of the *Works*, and it includes the story behind the publication of the *Chronicles*, which caused a minor scandal and affected the reputation of Bancroft and the *Works* by association.

NOTES FOR CONTRIBUTORS

1. All contributions and editorial correspondence should be sent to: The Editor, *Journal of American Studies*, Department of American Studies, The University, Manchester M13 9PL, England.
2. Articles should generally contain about 5000 words. Longer or shorter articles, or articles in two or more parts, may be accepted by arrangement with the Editor.
3. Submission of an article is taken to imply that it has not previously been published, or is not being considered for publication elsewhere.
4. Contributions should be clearly typed in double spacing, preferably on A4 paper, with a wide left-hand margin. Diagrams and maps may be included by arrangement with the Editor.
5. Footnotes should be used sparingly: in general, to give sources of direct quotations, references to main authorities on disputable questions, and evidence relied on for a new or unusual conclusion. They should be numbered in one sequence throughout the article, and should preferably be typed in double spacing at the end of the article.
6. Contributors should keep one copy of the typescript for correcting proofs.
7. Notes intended for the Editor or printer should be on a separate sheet.
8. First proofs may be read and corrected by contributors provided that they can give the Editor an address through which they can be reached without delay and can guarantee to return the corrected proofs to the Editor, by airmail where necessary, within ten days of receiving them.
9. Correction should be kept to an absolute minimum. It should be confined to errors of the typist or printer unless the Editor authorizes otherwise.
10. Contributors of articles and review articles receive 25 free separates. Extra copies may be ordered according to the scale of charges.
11. Contributors need not be members of the British Association for American Studies. Unsolicited typescripts can only be returned to overseas contributors who send International Reply Coupons (not postage stamps).
12. Contributors of accepted articles will be asked to assign their copyrights, on certain conditions, to Cambridge University Press, to help protect their material, particularly in the U.S.A.
