John Barleycorn Must Pay Compensating the Victims of Drinking Drivers

PAUL A. LEBEL

Paul LeBel proposes that state governments set up a supplemental compensation fund to aid the most seriously injured victims of drinking drivers, financed by a new tax on alcohol manufacturers and distributors. This fund would supplement the existing tort law system.

Except for the least serious accidents, in which most costs are covered by insurance, victims often must pay shocking amounts for long-term medical treatment and physical therapy. Lives are interrupted and savings are drained. Protection against catastrophic losses is inadequate.

LeBel's proposal is designed to correct this situation. He analyzes the present patchwork scheme of remedies available to accident victims and focuses on the major goals of victim compensation and accident cost internalization in the context of the drinking driver scenario. He also provides model legislation to set up a compensation fund that would place a greater share of the social costs of alcohol on the alcohol industry and its consumers.


