Directions to Contributors - Concise Version

Revised May 2003 (Online Submission)

The British Journal of Nutrition is an international peer-reviewed journal which publishes original papers, review articles, technical notes and short communications in English in all branches of nutritional science. Prospective authors should note that they (or their institutions) now retain the copyright of their material published in the BJN. As a contributor you are asked to follow the guidelines set out below. For detailed information on the presentation of the technical content of your paper please see the full version of the Directions to Contributors, as reproduced in the January issue, on The Nutrition Society web pages (http://www.nutsoc.org.uk/Publications/ directions.htm) or on the BJN online manuscript submission site (http://www.bjn.msubmit.net). Prospective authors may also contact the Publications Office directly on +44 (0)20 7371 6225 (telephone), +44 (0)20 7602 1756 (fax), or edoffice@nutsoc.org.uk (email).

Papers should be accompanied by a statement to the effect that the conditions laid down in the full Directions to Contributors are accepted. The statement should affirm that the submission represents original work that has not been published previously and which is not currently being considered by another journal. It should also confirm that each author has seen and approved the contents of the submitted manuscript. A copy of the 'Licence to Publish' form should be completed by all authors and submitted by post at the same time the manuscript is submitted on eJournalPress. The Licence to Publish (in lieu of copyright transfer) is reproduced in the January 2003 issue (vol. 89, no. 1) of the British Journal of Nutrition and is available on The Nutrition Society website (http://www.nutsoc.org.uk/ Publications/directions.htm).

Text. Papers should be submitted with double line spacing and margins of at least 2 cm on each side. Text should be printed without underlining or bold (except for scientific names). Standard abbreviations (e.g. Fig. and Figs.) and SI units should be used. **Manuscripts can be submitted as either PDF, Word, WordPerfect, EPS, Text, Postscript or RTF files. A Word processing format is required for production purposes once papers have been accepted.**

Title Page. The first page should include a concise, informative title together with the names and addresses of the authors. A contact name for correspondence should be given and telephone, fax and email addresses provided. Authors should supply three or four key words or phrases (each containing up to three words). A short title of up to 45 characters is required as a running head.

Abstract. Each paper should commence with an accurate and informative abstract, written as a single paragraph. It should be complete in itself and intelligible without reference to the text or figures, and should not exceed 250 words.

Tables. Tables should be reduced to the simplest form, and should not duplicate information in the text or figures. They should be typed on separate pages, one page for each Table, at the end of the article and carry headings describing their content.

Illustrations. The original illustrations should accompany the submitted manuscript. Text figures, line drawings, computergenerated figures and graphs should be of sufficient size and quality to allow for reduction by half or two-thirds. Half-tone photographs are acceptable where they clearly contribute to the text. Figure captions should be typed on a separate sheet and numbered corresponding to the relevant Figures.

References. References should be based on the name and year (Harvard) system. When an article has more than six authors, only the names of the first three should be given followed by *et al.* and please give abbreviated journal titles and conform to the following styles:

Citation of authors in the text should appear in the form: Dwyer *et al.* (2003) or (Dwyer *et al.* 2003). More than one author should be cited in chronological order as: (Fleischhauer & Arab, 2001; Jump, 2002).

Referees. Authors are asked to submit the names of up to four scientists who would be well-qualified to review the paper; however, no more than one such reviewer will be used. The email addresses and institutions of the named reviewers should be given, when known.

Proofs. PDF page proofs will be emailed to authors for checking, and should be returned within 3 days (by fax or Express mail) to the address given below.

Manuscripts. The *BJN* now operates an on-line submission and reviewing system (eJournalPress). Authors should submit to the following address: http://www.bjn.msubmit.net. If any difficulties are encountered please contact the Publications Office immediately.
