## ***THE ORIGINS OF MEDIEVAL JURISPRUDENCE***

*Pavia and Bologna, 850-1150* · Charles M. Radding

This book discusses how legal science emerged in northern Italy from the prescientific attitudes towards law of the early Middle Ages. Radding argues that, contrary to prevailing belief, medieval jurisprudence arose not in twelfth-century Bologna but in Pavia three centuries earlier. He reconstructs the working environment of the ninth-century Pavian judges, traces their dispersion, and investigates the subsequent origins of the Bologna school. 272pp. £20.00
