Gala Argent is an interdisciplinary scholar whose work concerns human—non-human animal intersections. She received her BA and MA in communication studies from California State University, Sacramento (California, USA), and her Ph.D. in archaeology from the University of Leicester (Leicester, UK). She currently serves as an adjunct assistant professor teaching cultural anthropology at Sacramento City College and animal studies through Eastern Kentucky University, and also has taught in departments of psychology, communication studies and art. She is currently editing a multidisciplinary volume dealing with the manner in which humans and horses might be seen to co-create and replicate mutually interdependent selves, identities and culture within various societies, past and present. She shares social worlds with birds, dogs, horses and other humans.

Brian Boyd is Lecturer in Discipline (Anthropology) and Program Director of the Center for Archaeology at Columbia University, New York. He is also Co-chair of the New York Academy of Sciences Anthropology Division. His research focuses on the later prehistory of the Levant, the politics of archaeology in Israel–Palestine, and human–animal relations. He currently co-directs the Wadi en-Natuf Landscape Project (Palestinian Territories) with colleagues from the University of Birzeit and Paris Sorbonne. His forthcoming book, *Beyond bones. An archaeology of human–animal relations*, will be published by Cambridge University Press.

Richard Bradley studied law before becoming a full-time archaeologist. He was appointed to Reading University in 1971, retiring in December 2013. He has been a Professor in Archaeology there since 1987. His main interests include ancient landscapes, monumental architecture, rock art, hoards and hoarding, field archaeology, and the prehistory of north-west Europe. He has carried out fieldwork in England, Scotland, Spain and Scandinavia. Recent publications include *The prehistory of Britain and Ireland* (2007), *Image and audience. Rethinking prehistoric art* (2009), and *The idea of order. The circular archetype in prehistoric Europe* (2012).

Marianne Hem Eriksen is a Ph.D. Research Fellow at the Department of Archaeology, Conservation and History, University of Oslo. She received her MA in archaeology from the University of Oslo in 2010, her thesis examining how Iron Age hall buildings were used in negotiations of symbolic power. Eriksen's doctoral research explores the socio-ritual significance of doors and entrances in Viking Age longhouses. The project, expected to be completed in 2015, examines possible ritual usage of doorways as liminal spaces, and pursues how embodied engagement with domestic space has prompted the door's metaphorical and ritual connotations. Eriksen is also interested in how boundaries in settlements reflect social organization, and the relationship between the house and its inhabitants. Other research interests include

settlement archaeology, architecture, Old Norse mythology and religion, ritual, and mortuary archaeology.

Yannis Hamilakis is Professor of Archaeology at the University of Southampton and co-directs the Koutroulou Magoula Archaeology and Archaeological Ethnography Project, centred around the excavation of the primarily Middle Neolithic tell site of Koutroulou Magoula, in central Greece. His main interests are the archaeology of bodily senses and of memory, the politics of the past, archaeological ethnography, social zooarchaeology and prehistoric Greece. In 2012–13 he was member at the Institute of Advanced Study, Princeton, New Jersey. Recent publications include *The nation and its ruins*. Antiquity, archaeology, and national imagination in Greece and Archaeological ethnographies (co-edited with A. Anagnostopoulos).

Terry Hopkinson is Lecturer in Early Prehistory at the University of Leicester. His interests include transitions in the Palaeolithic; cultural transmission and innovation; the relationships between practice, knowledge and ecology in the Palaeolithic; lithic technology; and archaeological theory. He has conducted fieldwork in Bosnia.

Andrew Meirion Jones is Reader in prehistoric archaeology at the University of Southampton (UK). He is the author of a number of publications on a variety of topics ranging from the philosophy of archaeological science to memory, colour, prehistoric monumentality and rock art. His most recent publications include *An animate landscape* (2011, with D. Freedman, B. O'Connor, H. Lamdin-Whymark, R. Tipping and A. Watson), *Prehistoric materialities* (2012), *Visualising the Neolithic* (2012, edited with A. Cochrane) and *Image, memory and monumentality* (2012, edited with J. Pollard, J. Gardiner and M. Allen). He is currently developing a project looking at the context and production of the decorated artefacts of Neolithic Britain.

Lars Larsson was appointed Professor at the Institute of Archaeology and Ancient History at Lund University, Sweden, in 1984 and retired in 2012. He has undertaken research in most prehistoric periods. In southern Sweden the studies have been focused on Mesolithic settlements, including bog sites and cemeteries. For several years his research has been aimed at a large long-term settlement site from the Iron Age (Uppåkra in southern Sweden). He has also been involved in several international projects, leading excavations on Middle Stone Age settlements in Zimbabwe and South Africa, megalithic tombs in Portugal, and Mesolithic mortuary practices in Latvia.

Kristlina Mannermaa is a Researcher at the University of Helsinki and specializes in zooarchaeology and animal osteology. Her PhD thesis, 'The archaeology of wings. Birds and people in the Baltic Sea region during the Stone Age', was published in 2008. Her current research topics focus on a broad range of human–animal relations in history and prehistory. Her special interest is in the understanding and interpretation of animal remains in hunter-fisher-gatherer burials in northern Europe.

Nick Overton is a Doctoral Research Student at the University of Manchester, focusing on exploring the relationships between human and non-human agents within the Early Mesolithic of southern Britain. His main research interest lies in analysing and interpreting faunal assemblages within explicitly non-anthropocentric frameworks, using established zooarchaeological methods to present detailed accounts of specific interactions and developing relationships between human and non-human agents in the past. He has recently published in an archaeology special of Society and animals, focusing on rhythm and interspecies participation within the European Mesolithic and Bronze Age (co-authored with Marcus Brittain). When not listening to folk music, Nick also has regular involvement in excavations at Palaeolithic and Mesolithic sites in the North of England and Wales.

Mark Pluciennik is a University Fellow at the University of Leicester in the UK. He gained his doctorate in archaeology at the University of Sheffield. For his doctorate he worked on the Mesolithic-Neolithic transition in southern Italy, and current field research involves Sicilian landscapes. As well as Mediterranean surveys, other research interests include archaeological theory and philosophy. Recent publications include 'Is narrative necessary?' in Ethnographisch-Archäologischen Zeitschrift and 'Theory, culture, fashion' in The death of archaeological theory?, and books on archaeological ethics (The responsibilities of archaeologists. Archaeology and ethics, 2001), archaeological approaches to the body (*Thinking through the body*. Archaeologies of corporeality, 2002) and hunter-gatherer historiography (Social evolution, 2005).





Guidelines for contributors

Archaeological dialogues is a broad, peer-reviewed journal for debating archaeology. Articles should be accessible to an audience which may be unfamiliar with the specific period and region discussed. Transparent writing is encouraged above abstruse reasoning. Jargon should be avoided and succinct writing is appreciated. We value good illustrations. These can include photographs, line-drawings and maps.

Procedure

The *Archaeological dialogues* publishing process includes the following steps: submission, evaluation, decision (acceptance, modification or rejection), copy-editing, proof-reading, publication, and distribution. In order to guarantee efficient and quality publication contributors are requested to adhere closely to the following guidelines:

- All manuscripts should be written in English. Manuscripts that seriously fail to conform to the guidelines will be returned to authors for revision before they will be considered.
- When submitting a contribution to *Archaeological dialogues*, it will be acknowledged on receipt. One of the editors will be the contact person for a paper throughout the entire process. If scope, quality and language are appropriate it will be sent to two anonymous referees for expert opinion. Usually within two or three months, the editors will inform you of their final decision. In the case of rejection, an editorial justification will be provided, including the original referees' reports. In the case of acceptance which may be conditional on revisions one of the editors will guide you through the rest of the publishing process. Before an article goes into print, authors will receive a copy of the proofs to check. The entire procedure between submission and appearance should take less than a year.

Types of contributions

Archaeological dialogues essentially publishes two types of papers, namely 'discussion articles' and 'notes'. The former are accompanied by published comments and a reply. Discussion articles are usually longer, they can be up to 8–9000 words whereas notes typically are around 4–5000 words. Discussion articles usually take longer to appear in print because of the time required for comments and reply. Review essays and interviews are usually solicited by the editorial board, but scholars with suggestions in this direction are encouraged to contact us.

Submission of contributions

Manuscripts are preferably received by email (*dialogues@cambridge.org*). Alternatively, a CD and hardcopy may be sent to: Archaeological Dialogues, c/o Jeremia Pelgrom, Koninklijk Nederlands Instituut Rome, Via Omero 10/12, 00197 ROMA, ITALY.

Authors are solely responsible not only for the contents of their manuscripts, but also for securing any legal rights or permissions to publish submitted material, including copyright-protected materials. The appropriate acknowledgements should be given in captions, endnotes, or elsewhere. Manuscripts should not be submitted to (nor should they have been published in) any other journal or publication.
