Intellectually vibrant and steeped in broad liberal learning, he endorsed an integrated view of human knowledge, an Aristotelian vision of politics, and exacting standards of literary craftsmanship. As an advisory editor, he held our feet to the fire of these ideals. If we published anything that failed to measure up to our declared standards of scholarship, he let us know about it, forthwith and candidly. Gerry was a devoted friend of *The Review*. We will miss him dearly.

INSTRUCTIONS TO CONTRIBUTORS

All manuscripts should be submitted in **QUADRUPPLICATE** to Professor Walter Nicgorski, Editor, *The Review of Politics*, Box B, Notre Dame, IN 46556. If the return of the manuscript is desired, a stamped, self-addressed envelope should be enclosed. All typewritten material should be double-spaced, including notes and quotations; photocopies of a good quality are acceptable. *The Review* follows the *Chicago Manual of Style* for standards of citation, punctuation and other editorial considerations. The normal length of manuscripts published is 8,000–11,000 words. Since manuscripts are evaluated anonymously they should not bear the author's name or institutional affiliation. Submissions should be sent with an **ABSTRACT** of 100–150 words. We assume, in accordance with APSA policies, that you have not submitted your essay to another journal. All correspondence regarding book reviews should be sent to Professor Peter R. Moody, Jr. at the above address.
