CONTRIBUTORS

NAOMI CHAZAN is a lecturer in African Politics and Coordinator of the Africa Research Unit of the Truman Institute at the Hebrew University of Jerusalem. She has specialized in the politics of socio-economic change in West Africa and published a number of articles on youth politics in Ghana and the Ivory Coast. She is currently engaged in research on comparative political cultures in West Africa.

KENT FORSTER is Professor of European History and Head of the Department of History at the Pennsylvania State University. In 1976-1977 he was Visiting Professor of European History at the University of Nairobi. A specialist in recent European Diplomatic History, he has only recently turned to European diplomacy and the East African scene.

FRED M. HAYWARD is Professor of Political Science and Chairperson of the African Studies Program at the University of Wisconsin, Madison. A specialist in African and comparative politics, he has written on national political integration, political information and political knowledge in Africa, problems of legitimation for military regimes, and political participation in Africa. He is currently working on a study of political attitudes in Ghana using time-series attitudinal data.

DIDDY R. M. HITCHENS is an Associate Professor of Political Science at the University of Alaska, Anchorage. Specializing in Comparative Political Behavior, she spent the period 1970-1974 on the faculty of the University of Ghana, Legon, and was concurrently engaged upon a Ford Foundation study of local government and politics in Ghana.

PETER KOEHN is an Associate Professor of Political Science at the University of Montana. He has published on Ethiopian urban politics and development administration, including "Urban Origins and Consequences of National and Local Political Transformation in Ethiopia," in *The City in Comparative Perspective*, edited by John Walton and Louis H. Masotti (Sage, 1976); and (with John M. Cohen) "Rural and Urban Land Reform in Ethiopia," *African Law Studies* XIV, 1 (1977).

VICTOR T. LE VINE is Professor of Political Science at Washington University in St. Louis, Missouri. A frequent visitor to Africa, he has published five books and numerous articles on African subjects. From 1969 to 1971, he was Professor and Head of the Department of Political Science at the University of Ghana, Legon. Research conducted during this period resulted in a book, *Political Corruption: The Ghana Case* (Hoover, 1975). During the first half of 1978 he was a Lester Martin Fellow at the Harry S. Truman Research Institute, Hebrew University, Jerusalem. His latest publication will be *The African-Arab Connection*, to be published by Westview Press early in 1979.

JAMES A. MCCAIN is an Associate Professor of African and Afro-American Studies at the State University of New York, Brockport. As a specialist in African politics, he is a frequent contributor to journals and anthologies. In 1975, he was a Visiting Lecturer in the Department of Political Science at the University of Ghana, Legon.

OYEKAN OWOMOYELA is Associate Professor of English at the University of Nebraska, Lincoln. A specialist in African Folklore, Theater, and Literature, he has published several articles in those areas, and his book *African Literatures: An Introduction* is now available from Crossroads Press.

MAXWELL OWUSU is both Associate Professor of Anthropology and Associate Research Scientist, Center for Research on Economic Development, at the University of Michigan, Ann Arbor. The author of *Uses and Abuses of Political Power: A Case Study of Continuity and Change in the Politics of Ghana* (University of Chicago Press, 1970) and of several scholarly articles on contemporary Ghanaian politics, he is currently completing a book-length study of representation, economic underdevelopment, and political change in Ghana. He spent the last summer in Ghana studying the work of Ghana's Constitutional Commission.

DONALD ROTHCHILD is Professor of Political Science at the University of California, Davis. A specialist in African international relations and comparative politics, his most recent publication (co-authored with Robert L. Curry, Jr.) is *Scarcity, Choice, and Public Policy in Middle Africa* (University of California Press, 1978).

ALBERTO SBACCHI, Ph.D., Professor of History at Atlantic Union College, is author of a number of articles published in Europe, Africa, and the United States on various aspects of the occupation, administration, and diplomacy of Italian East Africa. His forthcoming book, *Italian Colonialism in Ethiopia*, will be published by Mursia of Milan, Italy.

EARL P. SCOTT is an Assistant Professor of Geography and Director of the African Studies Program. A specialist in African marketing systems and rural economic development, his most recent publication is "Subsistence, Markets, and Rural Development in Hausaland" (*The Journal of Developing Areas*, 1978).

LILLIAN TRAGER is Assistant Professor of Anthropology at the University of Wisconsin, Parkside. She received her Ph.D. from the University of Washington in 1976. For her doctoral research, she studied the spatial and social organization of trade in a Yoruba marketing system in western Nigeria.
