# GOVERNMENT RESPONSES TO THE LATIN AMERICAN DEBT PROBLEM

edited by Robert Grosse

The Latin American debt crisis has been examined I from numerous perspectives. This volume specifically focuses on the most recent phase of the external debt problem: during the past decade, many of the indebted governments have worked to overcome a debt crisis and have embarked on paths of renewed economic growth. The contributors study five Latin American countries --- Chile, Brazil, Peru, Bolivia, and



Mexico - and analyze their success in dealing with the debt crisis. Also included is an analysis of the Brady Plans, which have been negotiated by five countries, and a comparison of ten countries' return to international creditworthiness, focusing on the factors that have contributed most to improvement.

#### Latin American Political Economy in the Age of Neoliberal Reform: Theoretical and Comparative Perspectives for the 1990s



In Latin America during the 1980s, the widely accepted model of economic development based upon import-substitution collapsed, triggering profound changes in relations among the state, civil society, and

the market. In its place, neoliberal strategies pursued market-oriented restructuring to achieve external adjustment, tame hyperinflation, and discipline public sector finance. However, more people are now poorer with only marginal opportunities for equality, and a few people still hold most of the wealth and control productive resources. Frequently, governments have implemented new stabilization and structural adjustment policies autocratically, undermining democratic politics and the broadening of citizens' rights. This volume advocates a fundamental rethinking of central issues.

#### Democracy, Markets, and Structural Reform in Latin America: Argentina, Bolivia, Brazil, Chile, and Mexico

Severe political and economic problems challenge the civilian governments that have emerged in Latin America over the past decade. While achieving a degree of stability, these governments remain threatened by serious obstacles to the democratic process. This volume addresses the problematic relationship between neoliberal strategies of economic restructuring and the process of democratic consolida-



tion. Highlighted are the connections between democratic politics and marketplace logic — a linkage reinforced by the "Washington Consensus" of free-market reforms promoted by policymak-

ers in the International Monetary Fund, the World Bank, and the U.S. government.
