Johan Skytte Prize in Political Science

The Foundation for the Chair in Eloquence and Government at Uppsala University has established an annual prize, the Johan Skytte Prize in Political Science, of 350,000 Swedish crowns (approximately 45,000 US dollars) to the scholar who in the view of the Foundation has made the most valuable contribution to political science. Research in all areas of the discipline will be considered: political theory, comparative politics, public administration and international relations.

The Johan Skytte Chair in Eloquence and Government was founded in 1622 and is today one of the oldest professorships in the world. Since its inception the department has been situated in the same medieval building, and the farms that were part of the initial donation still help to finance research, including this new prize.

The prize will be awarded for the first time at a solemn ceremony in Uppsala on October 1, 1995. The first laureate will be chosen by the Foundation on the recommendation of a Prize Committee.

Carrie Chapman Catt Research Prize

The Carrie Chapman Catt Center for Women and Politics in the political science department at Iowa State University announces the establishment of the Carrie Chapman Catt Research Prize for Women and Politics. These awards will be granted to two scholars who are embarking on significant research in the area of women and politics. The Carrie Chapman Catt Research Prize includes a \$1,000 award and travel expenses to Ames, IA where prizes will be awarded in March 1995. Recipients will be asked to present an overview of their research at a university colloquium.

Eligibility. Applicants may be scholars at all levels. However, preference may be given to graduate students and junior faculty.

Applications. Applications should consist of a scholarly curriculum vita and a detailed description of the research. This letter should address 1) the type of project undertaken including specific information about the research plan and a timetable for completion of the research; 2) the relationship of this project to previous research in the field of women and politics; 3) the anticipated contribution which this research project will make to the field of women and politics; and 4) a brief biographical sketch focussing on professional interests and experiences relevant to the project.

Journal Offers Two New Prizes

The *Journal of Policy History* announces two new prizes in honor of three of the founding members of its editorial board. These prizes will be offered in alternating years. Each award carries an honorarium of \$250.

The Ellis Hawley Prize will be awarded to a junior scholar (untenured professor or graduate student) for the best *JPH* article published during the preceding two years. The first Hawley Prize will be announced in 1995.

The Robert Kelley and Aaron Wildavsky Memorial Prize will be awarded to the author of the best *JPH* article written by a senior scholar and appearing during the preceding two years. It will be given for the first time in 1996.

New Masters Degree in Professional Politics

The Suffolk University department of government announces a new graduate program, the Master of Science in Political Science, with concentration in Professional Politics. The first students will begin classes in September 1994.

This program is intended primarily for those seeking professional careers in politics—as specialists in campaigns and elections, lobbyists, organizers, or staff for elected officials—perhaps as elected officials themselves; to a lesser extent, it will also serve those who may wish eventually to pursue a Ph.D. in political science, but who feel the need for better preparation first.

The MS requires 30 semester hours (ten courses) of academic credit, including either an internship and internship-based research paper, or a master's thesis. All students must take four core courses: ethical issues in politics, advanced research methods, and two graduate seminars—in campaigns and elections and in legislation and lobbying.

Both full-time and part-time students are accepted. Tuition for 1994–95 is \$12,000; limited fellowship support is available.
