1. Original Articles are accepted on the condition that they have not been published elsewhere.

2. Manuscripts should be typewritten, on one side only of the paper, and well spaced.

The Harvard system of recording references should be used, e.g. GREEN, C., and BROWN, D. (1951) *J. Laryng. and Otol.*, 65, 33.

It is most important that authors should verify *personally* the accuracy of every reference before submitting a paper for publication.

3. Galley proofs and engraver's proofs of illustrations are sent to the author. Corrections, which should be kept to a minimum, must be clearly marked, and no additional matter added.

4. Blocks illustrating articles are normally paid for by the *Journal*. Authors may, however, be required at the Editor's discretion, to contribute towards the cost of these in cases where this is particularly heavy.

5. Orders for reprints should be sent when returning galley proofs, and for this purpose special forms are supplied.

6. Authors of original communications on Oto-Laryngology in other journals are invited to send a copy, or two reprints, to the *Journal of Laryngology*. If they are willing, at the same time, to submit their own abstract (in English, French, Italian, or German) it will be welcomed.

7. Editorial communications may be addressed to THE EDITOR, *Journal of Laryngology*, c/o HEADLEY BROTHERS LTD, 109 Kingsway London WC 2.

8. The annual subscription is three guineas sterling, post free, and is payable in advance.







THE MEDICAL RESEARCH COUNCIL's Otological Research Unit has vacancy for well qualified otologist with good experience of clinical otology to work mainly, but not exclusively, on clinical and pathological investigations of otoneurological problems.

Remuneration, in the form of a grant from a private fund, will be between £1,000 and £1,200 per annum depending on age, qualifications and experience.

The duration of the appointment will be six months in the first instance but may be extended up to two years.

The post is open to candidates from abroad: a personal interview in London will be necessary before a final selection is made.
