

Instructions to Authors

Submitted articles and editorial correspondence should be sent to: The Editors, *Economics and Philosophy*, Department of Philosophy, University of Bristol, 9 Woodland Road, Bristol BS8 1TB, UK. Books for review in *Economics and Philosophy* should be sent to Professor M. Schabas, Dept of Philosophy, York University, 4700 Keele Street, North York, Ontario, Canada M3J 1P3. Correspondence may also be sent by e-mail to: Economics-and-Philosophy@bristol.ac.uk.

The journal publishes papers in English only. However, the editors are willing to consider initial submissions in French, and advise the authors whether to resubmit an English version. The final decision will be made on the basis of the English version only.

Please send four copies of submitted articles, in double-spaced type. We are pleased to receive copies printed on both sides of the paper. The copies sent to referees will be anonymous, so the author's name and address should appear on a separate title page and not in the rest of the article. Please also remove other clues to your identity. Repeat the title of the article at the beginning of the text to be sent to referees. Submitted articles will not be returned to authors.

Authors of accepted articles will be asked to prepare a final version in the journal's style, following instructions that the editors will provide, and to submit it on disk together with a version on paper.

Submitting an article to *Economics and Philosophy* implies that it has not been published elsewhere and is not being considered for publication elsewhere. Authors must obtain written permission to publish any material for which they do not own the copyright. They will be asked to assign the copyright of their article, under certain conditions, to Cambridge University Press. Authors of articles will receive 25 offprints of their article free of charge; additional copies may be purchased if ordered at proof stage on the form provided. (In the case of joint contributions, offprints will be sent to the first named author unless otherwise requested.)

Richard D. Arneson is professor and chair of the Department of Philosophy at the University of California, San Diego. He writes on issues in political philosophy, usually issues involving distributive justice. He is completing a book on this topic. His essay 'Autonomy and preference formation' appeared in *In Harm's Way*, a collection edited by Jules Coleman and Allen Buchanan (Cambridge University Press, 1994).

Roger E. Backhouse is Reader in the History of Economic Thought at the University of Birmingham, England. He is author of *A History of Modern Economic Analysis* (1985), *Economists and the Economy* (1994), *Interpreting Macroeconomics* (1995) and two macroeconomics textbooks. He is currently working on a book on the concept of progress in economic thought.

Pierluigi Barrotta is researcher in philosophy of science at the University of Pisa. He studied philosophy at Pisa and economics at the London School of Economics and Cambridge University (UK). He is author of *Gli argomenti dell'economia* (1992) and is currently working on an English book in general philosophy of science, entitled, *Scientific Dialectics. For a New Critical Rationalism*.

David Estlund is Associate Professor in Philosophy at Brown University. He works in moral and political philosophy, with an emphasis on the theory of democratic legitimacy. Currently he is writing a book on the political economy of health care in the United States. He is a member of the Executive Committee of the Central Division of the American Philosophical Association.

Jean Hampton is Professor of Philosophy at the University of Arizona. She is the author of *Hobbes and the Social Contract Tradition* (Cambridge University Press, 1986) and *Forgiveness and Mercy* (with Jeffrie Murphy). She is the author of

many articles in moral and political theory and decision theory and is presently working on a book on rationality and metaethics called *A Theory of Reasons* (Cambridge University Press, forthcoming).

Hans Jørgen Jacobsen has a Ph.D. in economics and is Associate Professor at the Institute of Economics, University of Copenhagen.

Cristina Marcuzzo is Associate Professor of Economics at 'La Sapienza' in Rome. Jan Österberg is a lecturer in moral philosophy at Uppsala University, Sweden. He is the author of *Self and Others: A Study of Ethical Egoism* (1988) and is currently working on a book on literary interpretation.

Wlodek Rabinowicz holds a chair in practical philosophy at Lund University, Sweden. He is the author of *Universalizability. An Essay in Morals and Metaphysics* (Dordrecht, 1979) and of several papers dealing with utilitarianism, causal decision theory, sequential choice, modal logic and belief revision.
